VAT in Web 3.0 - Crypto, NFT, Blockchain & Co.

Experts: Dr. Aleksandra Bal, Dr. Markus Müller

In recent years, blockchain technologies have opened up new sources of income extending beyond the now well-known trading of cryptocurrencies. In terms of VAT, the tax authorities have not yet managed to untangle non-fungible tokens (NFTs), validation of transactions through so-called staking pools, "gifting" of tokens (airdrops), metaverse transactions, to name just a few. In these cases, questions of VAT law arise at practically all levels of the test scheme - starting with the status as taxable person, determining the place of supply and the applicable VAT rate, and ending with the deduction of input VAT. Players in Web 3.0 are urged to assess their business models using the VAT scheme of the analogue world which is older than the internet.

VAT in the Digital Age I - Single VAT Registration

Experts: Fernando Matesanz, Andrea Springer

One of the pillars of the ViDA proposal is the "Single VAT Registration". It is intended to allow companies doing intra-EU activities to do so under a single VAT number. The aim is not to have a European VAT number but to reduce the number of situations where it is necessary to register in different countries. To this end, some of the measures that are on the agenda are extending the application of the reverse charge, widening the scope of OSS or the approval of a new special scheme.

Customs and VAT issues in relation to import and export

Experts: Emmanuel Cotessat, Dr. Hannes Gurtner

The broader application of the ECJ case Weindel Logistik to imports, where in most cases VAT can only be deducted by the owner of the goods, combined with specific domestic reverse charge and VAT registration rules, trigger new challenges for industries. R&D flows, industrial procurement under consignment schemes, inward processing relief exits, imports by non-taxable persons, are some examples.

VAT in the Digital Age II - Digital reporting

Experts: Tomasz Michalik, Angelo Pisanò

Recent years show the progressive fragmentation of the EU VAT system. New national reporting requirements and new e-invoicing rules already applied or soon-to-be-applied in different Member States make an EU VAT system less harmonised and keeping a pan-European compliance more and more difficult and costly every year. Would a newest EU Commission proposal ("VAT in the Digital Age") stop this process and make an EU single market great again?

Optional reverse charge - a country comparison

Experts: Emmanuel Cotessat, Fabiola Annacondia

The Member States have various options to introduce the reverse charge mechanism in their country for different activities. Exploring these options and the intended introduction of a reverse charge mechanism following the ViDA proposal will give a better understanding of the possibilities to do business in the various Member States and avoid unpleasant surprises.

When are the fixed establishments finally fixed

Experts: Alexis Tsielepis, Raymond Feen

With every new decision of the European Court of Justice another question is referred to the Court and a new attempt is made by a Member State to fix the question: is this a fixed establishment? What drives the Member States to ask these new questions and what do we need to fix the fixed establishments.

Platforms and VAT

Experts: Diana Ellenberg, Dr. Matthias Oldiges

In recent years, the trend has continued that the obligations under VAT law are increasingly being transferred to platforms for reasons of effective VAT collection. This applies to both supplies and services via platforms. In addition, the draft directive for the "VAT in the Digital Age" initiative published on 08.12.2022 contains extensive proposed changes for the platform economy. Most recently, with the DAC7 Directive, further reporting obligations on digital platforms were implemented into national law.

Cases of the European Court of Justice

Experts: Dr. Hannes Gurtner, Prof. Dr. David Hummel

Every month the European Court of Justice produces new case law, which may impact your business. In this session, a number of new and pending cases, which need to be taken into account in your day to day practice, will be discussed.

TOMS: Margin Scheme or Trap? The challenges for businesses

Experts: Alexis Tsielepis, Dr. Hans-Martin Grambeck

Introduced in the 1980s and made up of only a few articles in the VAT legislation, the special Tour Operators Margin Scheme (TOMS) for VAT has been interpreted differently across the EU. The purpose of the session is to examine the inherent problems and the challenges that businesses face, as well as the discussions taking place concerning the future of the special scheme.

Did you know about the fraud or should you have known

Experts: Dr. Roelof Vos, Ron Jeronimus

According to the case-law of the European Court of Justice, the rights of a taxable person can be refused if he knew, or should have known, that, by the transaction concerned, he was participating in a (chain)transaction involving fraud. We see a tendency that the benefit of the rights laid down in the VAT Directive are refused on a larger scale. During this interactive session you will find out when it is allowed to refuse these rights and who has the burden of proof.

Influencer and VAT

Experts: Dr. Markus Müller, Fabiola Annacondia

Influencer marketing has grown into a billion dollar business in recent years. The media reach of influencers is a magnet for possible collaborations with companies in almost all sectors. However, with growing revenues, the importance of tax issues also increases: the question often arises as to how, among other things, the transfer or (permanent) loan of clothing, accessories, cars, etc. is to be assessed for VAT purposes and whether an input VAT deduction is possible. The workshop will cover the most relevant topics, such as influencer business models, case studies on the most common remuneration models, proper exchange of receipts and securing and optimising input VAT deduction.

30 years chain transactions

Experts: Raymond Feen, Tomasz Michalik

Despite many attempts to introduce a definitive system we are still coping with a transitional system introduced 30 years ago. Is there still room for improvements, can we still learn from recent case law from the European Court of Justice. Occasionally the Court introduces important new views or finetunes conditions of VAT exemptions for cross border trade. Since 2020 there are new developments on the B2B2B and B2B2C chains. These simplifications introduced have made chain transactions more complex.

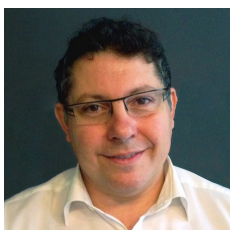

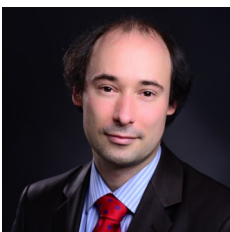
